Greetings to all,

Thank you to all the members that showed up at the March Meeting. I believe it was around 20 which seems low to me with a vote on a large dues increase.

As of the March Meeting the membership is at 75.

At the March 28th Meeting we had open discussion on the motion to raise the club dues in 2019 and the motion was put to a vote. The membership present voted better than 2 to 1 to approve the dues increase. Just a side note the Board abstain from voting on this matter as we wanted it to be up to the membership.

Starting in membership year 2019, the Canyon Crosswinds annual dues will be \$250 per year for all Memberships except Junior Membership.

Junior Membership will be \$80 per year.

New Membership will be \$250 and there will be no Runway Fee.

Based on a renewing membership of 75 this will bring the Club \$18,750, less our current fixed cost of \$6000, will leave the club \$12,750.

At this rate it will take 3 years minimum to make more major improvements

at the field if the membership remains constant and the fixed cost remain the same.

This proposal would be a monthly cost to a member of \$20.83. So start saving you money to be prepared for the dues increase.

At the April Meeting nominations for Club Officers will open. The offices open are President, Vice President, Secretary, and Treasurer. We will again open nominations at the May meeting with elections being at the June meeting.

Feel like you have something to offer the Club, or better ideas on how to run the club, or would like to be on the board then come to the meeting and throw your name into the ring.

The Club will be having a Swap Meet on Saturday May 5, 2018 at the field. Bring what you have and money to buy.

The Warbird Fun Fly is scheduled for Memorial Day Monday May 28, 2018. Flying is open to all aircraft.

The three trailers remaining at the field should be gone by the time you get this. The scheduled pick up date is April 3rd.

Thanks to Bob for the nice clear Treasurer's Report. I hope it continues to make it to the newsletter. I believe this should be in the newsletter each month so

that all members can see where their dues go.

We still have some Power Master 15% nitro fuel. The fuel is in 1 gallon sealed cans and is available for \$20.00 a gallon cash only. See any of your elected Club Officers and they can get it for you.

The Board welcomes your ideals to make the club a better place for all members. We also welcome your criticism as long as it's constructive criticism. Remember your Board does the job for free and if you are unhappy with the Board or their actions then feel free to step up and run of office.
