## CCW BOARD UPDATE MAY 7, 2020

JUST A SHORT NOTE TO THE CANYON CROSSWINDS MEMBERSHIP.  
HOPE THIS UPDATE FINDS YOU AND YOUR FAMILIES HEALTHY AND SAFE.

**CANYON CROSSWINDS FIELD IS OPEN FRIDAY MAY 8, 2020:**

ON WEDNESDAY MAY 6, 2020 THE LOS ANGELES COUNTY HEALTH SAFETY OFFICER ANNOUNCED THAT THE SAFER AT HOME ORDER WAS BEING MODIFIED.

THIS MODIFICATION WILL ALLOW THE CANYON CROSSWINDS BOARD TO REOPEN THE FIELD ON FRIDAY MAY 8, 2020 WITH THE FOLLOWING REQUIREMENTS:

- **PROPER SOCIAL DISTANCING (A MINIMUM OF 6 FEET) SHALL BE MAINTAINED AT ALL TIMES.**
- **FACE COVERINGS SHALL BE WORN WHEN THERE IS MORE THAN ONE MEMBER PRESENT AT THE FIELD.**
- **NO VISITORS WILL BE ALLOWED TO THE SITE AT ANY TIME.**
- **NO MEMBER SHALL BRING ANY GUEST FLYERS TO THE SITE.**

IF YOU DESIRE HAND SANITIZER, THEN BRING YOUR OWN AS I CAN NOT FIND ANY TO PUT AT THE FIELD. THERE IS SOME INSIDE THE ANDY GUMP.

THESE NEW OPERATING RULES **SHALL** REMAIN IN EFFECT UNTIL SUCH TIME AS THE LOS ANGELES COUNTY HEALTH SAFETY OFFICER MODIFIES THE SAFER AT HOME ORDER TO REMOVE OR REDUCE ANY RESTRICTIONS.

**FAILURE TO ADHERE TO THESE RULES MAY RESULT IN CANYON CROSSWINDS MEMBERSHIP TERMINATION.**

WITH THE ORDER BEING RELAXED I STILL WANT TO REMIND ALL OF YOU THAT COVID-19 IS STILL WITH US AND STILL A HAZARD TO ALL, SO WITH THAT IN MIND REMEMBER THAT ANY CONTACT WITH ANY MEMBER AT THE FIELD IS ALSO CONTACT WITH ANY PERSON THEY HAVE BEEN IN CONTACT WITH.

SAFER AT HOME IS STILL IN PLACE.
